NOTES:

(1) Seminary services fees are levied on **all** matriculated students, **whether or not** they are taking courses that semester, unless on officially approved leave of absence from study.

(2) Fee applies to all students who bring cars onto campus because of campus residence or participation in courses. Fee accompanies registration of vehicles with Security. Registration grants the privilege to park on campus but does not guarantee a place to park.

(3) Fee applies only to students who have previously been placed in collection, satisfied their indebtedness, and reapplied for admission.

(4) Participation in the Health Plan is mandatory at all ELCA seminaries for all students on internship or enrolled more than half-time (for more than 2.5 units in any semester). Students may waive coverage by providing proof of participation in another group coverage plan.

(5) Added to rent will be a 6% surcharge for utilities. Apartments and communal houses are unfurnished but include refrigerator and range.
